




# Upsilon Tau Omega Chapter



Southern Prince George's County Community Charities (SPGCC), Inc. awards the Sylvia Avery Memorial Scholarship, in the amount of \$1,000 to assist a student majoring in Education to continue his/her studies at Morgan State University. The scholarship is awarded on the basis of academic achievement, financial need and desire to continue higher education. All Education majors at Morgan State University meeting the following criteria are encouraged to apply for the Sylvia Avery Memorial Scholarship through SPGCC, Inc.

1. The applicant must be in good academic standing with Morgan State University;
2. The applicant must complete a 1000 word typed essay addressing the following points:
  - "The Advantages/Benefits of Becoming an Educator."
  - "Why Education is Important to Me"
  - "How I Plan To Use My Education To Impact Others."
3. The applicant must be currently enrolled at Morgan State University and have completed the previous semester at the University.
4. The applicant must have officially "declared" Education as his/her major (proof must be submitted).
5. The applicant must submit two (2) letters of recommendation from educational professionals at Morgan State University who can attest to the applicant's character and desire to become an Educator. One of the letters of recommendation must be from an Academic Advisor or the applicant's current or past Professor.

**Note:** *If no eligible applicant is identified based on the criteria of having a declared major in Education, applicants outside this area who satisfy the remaining eligibility requirements may be considered by the SPGCC, Inc. Scholarship Committee.*

## SCHOLARSHIP INSTRUCTIONS

### ELIGIBILITY REQUIREMENTS:

To be eligible students must meet the following criteria:

- Be a high school senior.
- Reside in Prince George's County, Maryland.
- Attend a high school or be enrolled in an approved home school program in Prince George's County, Maryland.
- Have plans to pursue an Associate's or Bachelor's degree on a full-time basis at an accredited two (2) or four (4) year college or university.
- Have a minimum cumulative grade point average of 2.5.

### APPLICATION PROCESS:

- Complete the enclosed application, indicating the type of scholarship applied for.
- Applicants for the "need" scholarship must also submit their parent/guardian's 2016 W-2 or tax return.
- Submit your 12th grade 1st quarter grades.<sup>1</sup>
- Submit a sealed official transcript. For high school seniors, this must include grades 9-11. The transcript must reflect the cumulative grade point average and must have the signature of an authorized school official.
- Submit two (2) recent letters of recommendation in a sealed envelope. Letters of recommendation may come from a guidance counselor, teacher, minister, employer, coach or community leader. All letters must have an original signature.
- Submit two (2) Evidence of Community Involvement forms.
- Submit a typewritten essay, at least 250 words, but no longer than 350 words, addressing the following topics:

*Considering the current political, economical and social events affecting our country, what issues do you feel affect our youth today. If given the resources, what community project would you implement to address your concerns?*

Essays will be evaluated on language mechanics, coherence and unity, clarity of expression, and focus on the topic. Please place your name at the top of your essay. If selected to participate further in the process, you will be invited to make a 15-minute presentation regarding your essay.

- Applications must be signed by the student as well as the parent/guardian.
- Application documents requiring original signature(s) must be mailed and received by February 1st.

### PRESENTATION OVERVIEW:

You may be invited to participate further in the process by taking part in a 15 minute presentation interview regarding your essay. If so, you will be notified of the date, time, and place of the interview. Presentation interviews will be evaluated on communication skills, poise and posture, quality of presentation, creativity, and appropriateness of attire.

SELECTION:

Applicants will be evaluated based on their complete submission. Selection decisions will be made based on the overall rating of the package submitted as well as the presentation interview.

Candidates who accept a full scholarship (all expenses paid) from a college or university will forfeit all rights to receive a scholarship through the ICC Scholars Program.


